ORIGIN: The Netherlands

GENERAL The product shall be prepared from fresh sound raw material that is free from all toxic residues and taints and shall comply with all current UK/EU Food Legislation. The product is intended to be used as ingredient that is further processed and heat-treated before final consumption.

INGREDIENTS Mushroom 100% Declare as: Mushroom
(*Agaricus bisporus*)

PROCESSING Mushrooms are delivered fresh to the factory, each load is quality assurance sampled for foreign material and physical defects. The load is then put in a chill store (3°C) before washing, trimming and inspection before freezing to -18°C or below.

PACKING During packing the mushrooms are inspected before weighing and filling into blue poly lined cartons. The cartons are Best Before and Production date coded, check weighed, metal detected, palletised and stretch-wrapped before being returned to store at -18°C to await despatch to the UK, at -18°C.

DEFECT TOLERANCES

Per 500g

DEFINITIONS OF DEFECTS

Clumps

Due to the collection method utilised during production the mushroom may be “touch” welded i.e. lightly frozen into a large clump. However this touch welding will break up when the carton is dropped onto the floor.

Foreign Material

This includes any material other than that derived from the mushroom or defined as EVM, such as insects, pieces of insects, wood, glass, stones, metal, paint, grease, oil, foreign vegetable material or any other material which would render the product unacceptable.

EVM

This includes any free vegetable matter which is derived from the mushroom e.g. root-like hyphae.

Size

The mushroom is collected by grading out during production using a 12mm diameter screen.

The below minimum numbers of samples should be inspected and average result to be out-of-spec.

ORGANOLEPSIS (Carried out on a thawed sample.)

COLOUR

White or creamy coloured mushrooms. There may be very slight non-uniformity in colour amongst the mushrooms.

FLAVOUR

Full characteristic chestnut mushroom flavour. May be slightly earthy, with no harsh flavours.

TEXTURE

Uniformly firm and tender, yielding to the bite.

ANALYTICAL

SO₂ levels shall be no greater than 10ppm.

WEIGHT CONTROL

The product shall be packed to minimum weight.

METAL DETECTION

All cartons shall be passed through a metal detector. The system shall be tested at least every 2 hours using ferrous, non-ferrous and stainless-steel test pieces.

BEST BEFORE DATE

The product shall be twenty-four months following the month of packing. Minimum BB date on delivery: 6 months.

TRACEABILITY INFO

Production date or Lot number printed on the label as well as customer order number and/or delivery date.

STORAGE CONDITIONS Keep frozen at - 18°C at all times.

CARTON LINERS

Blue food grade polythene liner of a minimum thickness of 30µm.

CARTONS

Corrugated fibreboard of glued construction, no metal staples to be used. Shall be sealed using blue adhesive tape.

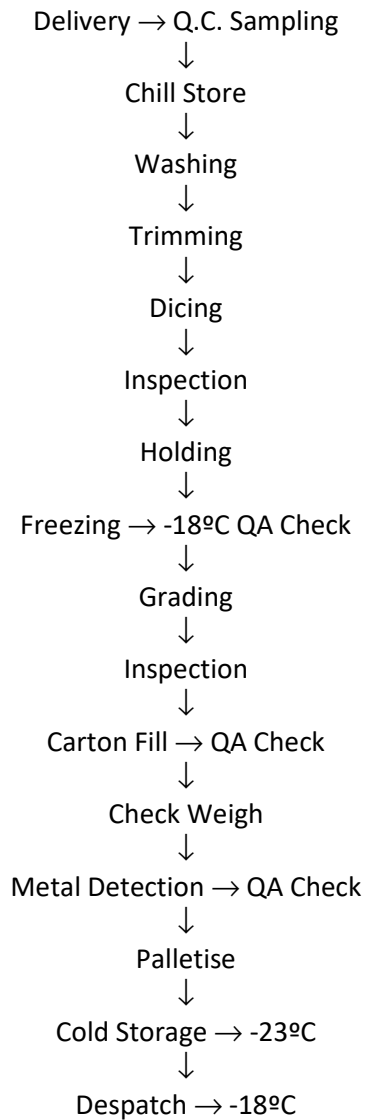
